(License points listed in parenthesis after violation)

You may pay many tickets without appearing in court. The amount is sufficient if payment reaches the Court on or before 14 days from the date you receive the ticket.

IMPORTANT NOTE: *If your citation was issued in a construction zone, school zone or at an emergency scene, contact the court for fine and cost amount and points.*
